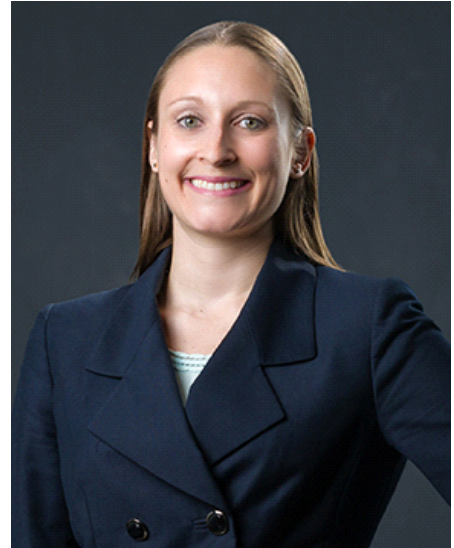
Liz Stamoulis leads the firm's intellectual property practice with a focus on transactional law.
